

License Conditions of the Institute of Asian, African, and Middle Eastern Studies for Papers Contained in Its Publications

| Reproduction or reprint in printed media | <p>1. The author may copy or reprint without permission from the Institute of Asian, African, and Middle Eastern Studies (the "Institute") if the author: (1) does not use the original pages as is; and (2) indicates the source clearly. If the author satisfies neither of these conditions, he/she shall obtain permission from the Institute.</p> <p>2. With respect to the papers in the <i>Sophia Journal of Asian, African, and Middle Eastern Studies</i> (or <i>The Journal of Sophia Asian Studies</i>), the author may reproduce and distribute offprints of his/her paper presented to him/her by the Institute without permission from the Institute.</p> <p>3. The author may reprint his/her paper in, or attach it to, a report submitted to an organization to which he/she belongs or which provides a research grant to him/her. In this case, the original pages may be used conditional upon clear indication of the source.</p> | <p>He/she shall obtain permission from the Institute by sending a letter to the Director.</p> <p>A: When the location of the author of the paper (or his/her bereaved family member) is known, the Institute shall confirm that the author (or his/her bereaved family member) gives permission and determine whether or not reprinting is suitable, and then determine whether the Institute permits the reprint or not. However, even if the author gives permission, in principle, publication using the original pages shall not be permitted.</p> <p>B: When the location of the author of the paper (or his/her bereaved family member) is not known, the Institute shall determine whether or not to permit reprinting. However, in principle, publication using the original pages shall not be permitted.</p> |
| Reproduction or reprint in digital media | <p>A: With respect to digital versions of papers published in an organizational repository of Sophia University by the Institute:</p> <p>The author may publish his/her paper using an electronic medium such as an organizational repository on a server owned by him/her or administered by an organization to which he/she belongs without permission from the Institute if he/she: (1) includes a link to the full text (original pages in PDF format) published by the Institute using an electronic medium; (2) indicates the source clearly; (3) indicates clearly that the Institute is the copyright holder; and (4) publishes it after the Institute publishes the full text using an electronic medium. If any of the requirements above is not satisfied, permission shall be obtained from the Institute.</p> <p>B: With respect to papers for which a digital version is not published in an organizational repository of Sophia University by the Institute: Permission shall be obtained from the Institute. The author shall send a letter to the Director in order to request permission.</p> | <p>He/she shall obtain permission from the Institute by sending a letter to the Director.</p> |
